Last year we provided support to 143,648 disadvantaged children and young people in 94 communities across Australia, a 19% increase on the prior year.



### YOUR QUESTIONS ANSWERED

### Q. HOW DOES WORKPLACE GIVING WORK?

Workplace Giving, or Payroll Giving, is simple and easy to set up. It enables your employees to make donations pre-tax through your payroll system.

Employees need to contact their Payroll Office to nominate the amount they would like to donate or sponsor. If you don't have an internal Workplace Giving form for your employees to use, we can provide you with one. Then, your Payroll office works with us to either set up a new account, or if your workplace has an existing program in place, we'll simply add the employee as a donor.

The donation amount is deducted each pay cycle after superannuation is calculated but before deducting PAYG tax.

## Q. WHAT REMITTANCE ADVICE DOES THE SMITH FAMILY REQUIRE?

Please contact The Smith Family using the details below to receive an easy Step-by-Step Guide about how to deposit your employees' donations and how to provide an employee donation deduction listing.

It is a requirement for any organisation providing a Workplace Giving program to provide a donation deduction listing. It can be automatically or manually generated. In the case of manual generation, it should be noted that we require the name and amounts only of the employees with a sponsorship, not those giving a general donation.

#### O. WHAT RECORDS DO I NEED TO KEEP?

You will need to keep a copy of authorisation forms from your employees and a record of the total amount of donations made from each employee's pay.

At the end of the financial year, employees' donations will be summarised on their annual PAYG payment summary. We will also send you an acknowledgment of receipt of total funds donated by your employees for the year.

#### Q. HOW DO I SET UP CHILD SPONSORSHIP THROUGH WORKPLACE GIVING?

Child sponsorship through The Smith Family matches employees with a specific child in need. Sponsors receive updates about their sponsored children and have the opportunity to communicate with their sponsored children.

We can set up a child sponsorship arrangement for any organisation that is able to administer it. To set up child sponsorship we need the employee's personal contact details and their company details, so their payments can be appropriately separated. We will also require a Workplace Giving donation deduction listing from your organisation each pay period. When we receive the donation deduction listing, we need to be able to identify payments from each sponsor and apply the correct amounts to their pledge record.

This deduction listing each pay period needs to confirm the name and amount given by the sponsoring employee. Note that we only require the name and amounts of the employees with a sponsorship, not those giving a general donation.

### Q. CAN OUR COMPANY MATCH EMPLOYEE DONATIONS?

Yes. This is a great way to show employees your commitment to corporate social

responsibility and double the impact of your employees' donations to the charities that matter to them.

# Q. CAN YOU HELP US TELL EMPLOYEES THEY CAN DONATE TO THE SMITH FAMILY THROUGH WORKPLACE GIVING?

Yes. We can provide you with materials like posters, brochures or slides to promote Workplace Giving to your employees, or we can send a representative to talk to you and your employees about how their support helps disadvantaged kids.

# Q. WILL THE SMITH FAMILY PROVIDE COMMUNICATIONS ABOUT THE IMPACT OF SUPPORT?

The Australian Charities Fund's research revealed that six out of 10 Workplace Giving donors wanted more communication on

specific projects. And non-donors were even more interested in information on real life stories.^

We can send you copies of our regular electronic newsletters which feature real life stories about the impact of donations to The Smith Family. You may wish to circulate this to your employees via email or your intranet.

# Q. WHAT PERCENTAGE OF DONATIONS HELPS AUSTRALIAN CHILDREN IN NEED?
