### 1. Your Acceptance

WELCOME TO THE WEBSITE OPERATED BY THE SMITH FAMILY ("THE SITE"). EACH REFERENCE IN THESE TERMS OF USE TO "THE SITE" INCLUDES ALL MATERIALS THAT WE MAKE AVAILABLE TO YOU ON THE SITE.

BY USING OR VISITING THE SITE, YOU AGREE TO COMPLY WITH THESE TERMS AND CONDITIONS OF USE ("SITE TERMS"). IF YOU DO NOT AGREE TO ANY OF THESE TERMS, DO NOT USE THIS WEBSITE.

If you are using the Site on behalf of any entity, you represent that you are authorised to accept these Site Terms on such entity's behalf (with each reference to "you" in these Site Terms being deemed to cover you and the entity in question).

The Smith Family may, at its sole discretion, modify or revise these Site Terms and policies at any time, and you agree to be bound by such modifications. ### 3. General Use of the Site — Permissions and Restrictions

A. - C. ### 4. Cookies

- A. *Cookies*. For each visitor to the Site, our server automatically recognises and stores the visitor's IP address. In addition, the Site uses cookies. We also use cookies for tracking the statistics of the Site. This allows us to better understand our users and improve the layout and functionality of the Site.
